

Memorandum of understanding (MOU)

The MOU is made on 24 July 2024

Between

Hitech Medicare Hospital, Udupi involved in providing health care service and having its hospital and office at NH 66, Ambalpadi, Udupi, Karnataka (hereafter referred as Hospital) represented by Dr. T.S Rao Whereas the first party – Hitech Medicare Hospital engaged in providing quality health care services for the people at reasonable cost.

Name of the organization: Hitech Medical Hospital, Udupi having contact number of its office Mobile No. 9448288190 having Email ID hospitalhitech@yahoo.com and having registered office located at NH 66, Ambalpady, Udupi, Karnataka.

Shri Madhwa Vadiraja Institute of Technology and Management (SMVITM) having its campus at Bantakal Udupi, Karnataka as second Party (hereafter referred as College) represented by **Dr. Thirumaleshwara Bhat , Principal**. Whereas the second Party- SMVITM is a Private Engineering College established under the AICTE (Establishment and Operations) Act 2005 and offer courses in various educational/ professional/ technical streams of academics.

Name of the institute: **Shri Madhwa Vadiraja Institute of Technology and Management, SMVITM** having contact number of its office 7483031199 having Email ID principal@sode-edu.in having its PAN AAIT57580B and having registered office located at Bantakal, Udupi, Karnataka state.

THE MOU NOW WITNESSTH AS FOLLOWS:

That the second party has approached the first party to provide health care services to the staff and student of the second party on chargeable basis and the first party has agreed to the request of the second party based on the following terms and conditions:

1. The second party shall approach the first party and request for the health care service of the staff and students of the second party. In case of ambulance service is required to shift the diseased person; the same shall be arranged by the first party with top priority. All the services offered by the first party shall be on chargeable basis.
2. The first party shall take extreme care while diagnosing and providing the health services of the second party. In case of emergency or in case of non-availability of adequate facilities for treatment, the same shall be informed to the diseased person of the first party and help them to shift the diseased person to other hospitals having adequate facilities
3. Payment of the health care expenses: The second party doesn't have any mechanism to provide the health care services of its staff or students at no cost. However, it will ensure the payment of various expenses of its diseased member on time. In some special cases, the second party may take care of health care expenses of its staff/ students. In such case advance information shall be given to the first party by the second party in writing.
4. The first party will co- ordinate and report to the second party over phone or email about status of its diseased employee/ student. Also the first party will coordinate with family members during their enquiries with proper responses.
5. The first party will provide one point of contact for emergency / serious patients admitted in ICU / NICU in the hospital for patients / family members and the management of the second party.

Duration of this MOU:

The scope of the MOU is limited to the health care services required for the Second Party for a period of one year from the date of signing by both the parties. The scope of this MOU valid up to 31 July 2026 for a period of 2 years and shall continue only after the renewal of this MOU at least 2 week prior to its seizure.

Jurisdiction

It is mutually agreed between the first and second party that they shall fulfill their part of respective obligations faithfully and shall not harm and prejudice the interest of one another, in the successful tenure of the agreement. Each party agrees that in case of any dispute arises between the parties; both parties shall try to settle the dispute amicably. In case the dispute cannot be settled amicably: each party agrees that any legal action or proceeding with this agreement shall be within the jurisdiction of Udupi, Karnataka court only.
