Pursuant to the UGC Communication at reference (3) and State Government approval ref (6), **Shri Madhwa Vadiraja Institute of Technology and Management, Bantakal, Udupi** an affiliated college under VTU, Belagavi has been conferred Fresh Autonomous Status based on the Eligibility Criteria mentioned in UGC Regulation for Autonomous Colleges -2023 for a period of **Ten** years starting from the academic year **2025-2026 to 2034-2035** subject to the following conditions.

#### Conditions:

1. The College shall abide by the provisions of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 and amended from time to time.
2. The College shall strictly abide by the Act, Statutes, Guidelines for Implementation of Academic Autonomy, Rules and Regulations of the Visvesvaraya Technological University (VTU), Belagavi existing and revised/amended from time to time.

#### **3. Maintaining Accreditation Status :**

NAAC	NAAC accreditation 'A' Grade CGPA 3.24 On four point scale valid up to 24-10-2029
NBA	The following programmes are accredited by NBA and valid upto 30-06-2027 : UG – Electronics & Communication Engineering and Computer Science & Engineering Hence, the College shall get its programmes accredited by the National Board of Accreditation (NBA) so as to maintain the accreditation status

4. The College shall send annual returns to the University every year by 31<sup>st</sup> March in the format notified from time to time.
5. The College shall send the list of admitted candidates to the University for Approval and generation of University Seat Numbers immediately after reconciliation against the University notification in this regard.

6. The College shall not permit any student to appear for the examination without the admission approval of University.
7. The College shall not permit any student to migrate from Non-Autonomous to Autonomous scheme within the college or from other Colleges/ University without prior approval of the VTU.
8. The College shall send the list of successful candidates approved in the Academic Council of the College for Conferment of Degrees or Certificates by the University within prescribed date(s). Successful candidates means students eligible for award of degree/s as per the applicable Rules/ Regulations existing and notified from time to time.
9. The College shall collect the fees as per the Notifications issued by University and Government from time to time.
10. Any other notification issued by the University from time to time shall be followed.
11. The College shall remit the Student Registration and other fees or any other fees to the University as notified in this regard from time to time.
12. The College needs to pay other applicable fees as prescribed by the University from time to time.
13. The College has to initiate steps to notify the status of autonomy for its stakeholders with intimation to the State Government & University.
14. The College shall pay any due/balance fee, if any to the University immediately.
15. Application for extension of Autonomy :
  - a) The college shall comply clause 7.5 of UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 and amended from time to time.
  - b) Due date to apply for extension to autonomy : October, 2034

This is with reference to the proposal submitted by Shri Madhwa Vadiraja Institute of Technology and Management, Udupi, Karnataka, affiliated with Visvesvaraya Technological University, Belgaum, for conferment of autonomous status.

The Commission, in its meeting held on 03.04.2025, has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to Shri Madhwa Vadiraja Institute of Technology and Management, Vishwothama Nagar, Bantakal, Udupi – 574 115, Karnataka affiliated to Visvesvaraya Technological University, Belgaum for a period of 10 years from the academic year 2025-2026 to 2034-2035, as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University is, therefore, requested to issue the necessary notification within 30 days regarding the grant of autonomous status to the College as per the above-mentioned UGC Regulations. The college shall apply to the University Grants Commission for an extension of autonomous status at least three months before the completion of the period of autonomy.
