**RESPONSIBILITIES:**

Complying with the directives of the Hon'ble Supreme Court of India (vide its order dated 16-05-2007) and AICTE Notification dated 01-07-2009(F.No.37-3/Legal/AICTE/2009), the above Anti-ragging Squad is formed for overseeing the implementation of the recommendations of the Anti-ragging Verdict.

This squad comprising teaching faculty / supporting staff, administrators and women representatives (various sections of the campus community) will have vigil, oversight and patrolling functions. It will be mobile, alert and active at all times and is empowered to periodically inspect places of potential ragging. It will make surprise raids on hostels and other hot spots. The squad shall investigate incidents of ragging, make recommendations to the Institution level Anti-ragging committee and shall work under the overall guidance of the said committee.

Each squad will visit various potential locations and hostels (as decided by the Chairman) both inside and outside the SMVITM campus, regularly & periodically on the allotted days from 8.45am to 5pm, will continuously monitor the situation / keep vigilance, will take all preventive measures to stop ragging and report all such cases to anti-ragging committee from time to time.
