The Trustees can co-opt with mutual consent any other person or persons as Trustee(s). The Trustees so co-opted shall hold office as Trustees for the period of three years from the date of co-option. They may be re-co-opted if the Trustees for the time-being so desire. The total number Trustees at any time shall however not exceed fifteen.

5. All the Trustees together be called as the Board of Trustees headed by a Chairman. Any question arising in the administration of the Trust shall be decided by a vote of the majority of the Trustees as are present and voting at a duly convened meeting with at least two third of the Trustees present, and the President of the meeting shall have a casting vote in case of equal votes. A resolution may also be passed by circulation. The Trustees will be honorary trustees and are not entitled to any remuneration. However, they would be entitled to traveling and such other expenses as the Board of Trustees may deem fit and reasonable.

6. The trustees can receive gifts/donations either from any one of them or from others in cash or in kind and the gift so received together with the initial sum of Rs. 1000 /- (Rupees one thousand only) shall form corpus of the trust.

7. The funds and properties of the Trust shall consist of:

- The sum of Rs. 1000/- which has been settled by the Author.
- Gifts/donations either in cash or in kind which may be made by any philanthropic institutions/persons or members of the public who are in sympathy with the aims and objects set out herebelow including any donations made for any such specified purpose or objects:
- Properties movable and immovable which may be acquired by the Trust by purchase, exchange, lease, gift or otherwise.

- w. To conduct implement, establish, operate any program, plan, scheme related to environment, ecology, afforestation, wild-life and such other related areas.
- x. To undertake any research, study or project in education, self-employment, self-training, environment, health and medical fields and such other fields, which are beneficial to the general public.

- y. To acquire movable and immovable properties including agricultural properties and transfer, exchange, gift, sell or otherwise dispose of such properties for achieving the aforesaid objects of the Trust.
- z. To borrow money from individuals, banks and other institutions for achieving any of the objectives of the Trust.
- aa. To generally promote the well-being of persons of all branches of human activity calculated to make them useful citizens and devoted to the service of humanity.

9. The Trustees shall have all powers as may be required for the proper conduct of the affairs of the Trust. The Board of Trustees can appoint any Governing Council for proper conduct of affairs of any Institution established by it for achieving the objects of the Trust and may delegate any of its powers to such Governing Council as are required for the administration of such institution.

10. The Trustees shall have the power to initiate prosecutions and defend legal proceedings as may be reasonable and proper for safeguarding the assets and properties of the Trust as also of the Trust Funds and interest. Any action taken by such Trustees in this regard shall be deemed to have been taken by the trust and ratified by all Trustees.

11. The Trustees may open any account or accounts with any Bank or Banks in the name of the Trust. The operations of the said Bank account or accounts shall be as decided by the Board of Trustees.

12. The Board of Trustees shall have power to borrow money from persons, institutions, banks for the purposes of achieving the objectives of the Trust.

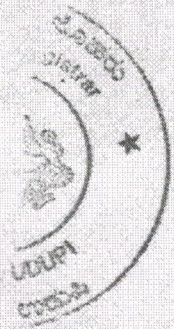

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees, but the same shall be transferred to another Charitable Trust, Society, Association or Institution whose objects are similar to those of this Trust and which enjoys recognition under section 80G of the Income Tax Act, 1961 and subject to approvals of the authorities and regulators concerned.

18. No amendment to the terms of this Deed shall be made without obtaining the prior written permission of the Commissioner of Income tax. However the amendments to be carried out shall not infringe the provisions of Sections 2(15)11 to 13 and 80G of the Income Tax Act 1961.

19. Similarly no amendment shall be made to this Trust Deed without prior permission of the regulators or authorities concerned with the educational activities of the Trust.

20. The Board of Trustees have power to amend the Trust Deed. Such an amendment shall be unanimously approved by the Board. Further the Board is empowered to authorize any Trustee to execute such an amendment.

21. The objects of the Trust shall be achieved without involving any activity for profit.

22. The Trustees and the members of their family shall not be entitled to the benefits of the Trust.

23. The Trust formed is irrevocable.
